

Solid Waste Disposal

More than 17.2 millions tons are disposed in GA each year National average is 4.6 lbs/person/day Georgia average is 7.5 lbs/person/day **Reasons:** Cheaper No serious push outside metro Atlanta

Solid Waste Issues

Total landfill capacity is 26 years Tipping fees is ~ \$25-30/ton vs \$70-75/ton in the Northeast No one wants a landfill in their neighborhood Building landfill in remote location only increases pollution (travel time)

Solid Waste Act

In 1996, the Act was revised to place a ban on yard trimmings.

"Yard trimmings" includes: leaves, brush, grass, clippings, shrub and tree prunings, discarded Christmas trees, nursery and greenhouse vegetative residuals, and vegetative matter resulting from landscaping development and maintenance other than mining, agricultural, and silvicultural operations.


Several attempts have been made to remove the ban.

The total generation of yard trimmings is estimated to be

1,195,564 tons per year.

Solid Waste Goals

Goal 1: Significantly *reduce* the amount of solid waste that has to be disposed

Goal 2: Ensure safe management of solid waste to protect human health and the environment

Department of Natural Resources

Types of SW Permits for Composting

- Exempt
- Yard trimmings
- Permit-By-Rule (PBR)
- Applies to a facility that processes no less than 75% (by weight) of solid waste generated at the PBR facility or facilities owned by the same person who owns the PBR facility
- Full Solid Waste Handling Permit

Solid Waste Regulations

Solid Waste Handling Permit for processing is required if:

 Solid waste such as garbage, food industry by-products, industrial or municipal sludge, or solid waste other than yard trimmings are being composted

Department of Natural Resources

Barriers to Composting in Georgia

- Lack of markets
- Low landfill tipping fees
- Logistical issues
- Feasibility of locating site near feedstock
- Obtaining Solid Waste Handling Permit
- Lack of compost awareness
